The current negotiations with the WHO endanger the sovereignty of Switzerland, as well as of all 194 WHO member states.

Dear Mr./Mrs.

The WHO in Geneva has been negotiating a new globally binding regulation on “health and climate measures” for some time now.

The deadlines have now been shortened. We need to act now!

The following deadlines have been set /shortened since our last correspondence:

- **Pandemic Treaty:** 18-month **domestic ratification deadline** from May 2024; this is not sufficient for a popular referendum in Switzerland.
- **IHR:** Rejection declaration by the government **by the end of March 2025**; this completely excludes the right of the Swiss people to have a say. The deadline can only be preserved by pressure from the parliament on the government. If this fails, the IHR will come into force.

The following new developments remain unchanged in both drafts:

- The previous advisory nature of WHO directives is being transformed into a binding command character.
- This is done without any examination of the failures identified by the WHO since 2020.
- Destruction of the doctor-patient relationship through the new WHO command authority.
- The International Health Regulations (IHR) in the planned version are significantly more threatening than the pandemic treaty in its current draft stage.
- This results in the severance of national legal jurisdictions and judicial powers.
- In Switzerland, the new IHR effectively means a **total revision of the Federal Constitution**, as the principles of the rule of law, separation of powers, national sovereignty, proportionality, and prohibition of arbitrariness according to Articles 5 and 9 of the Federal Constitution are eliminated. The deadlines for a total revision of the Federal Constitution **are insufficient**.
- The WHO claims, through its Director-General, **sole and comprehensive command authority** in matters of alleged medical threats to humans, animals, plants, and even the “climate”.

Take action now and preserve fundamental rights for our descendants

There is an urgent need for action from politicians, as the final vote of the WHO World Health Assembly on the revolutionary changes is scheduled for May 2024. **We therefore urge you, with reference to your duties**, to give the WHO project presented here your full and critical attention in the coming weeks. Because not acting in the interests of the Swiss people would not only be fatal, but would have serious consequences for every single parliamentarian. **Silence is considered consent, which is of course clearly defined in law and will be prosecuted and punished.**
